Minutes of the Council Meeting held on Monday 5 February, at 7.30 pm in the Lower Town Hall

 - Cllr Swales declared a DPI in item 168.1.2, planning application 2018/18890/VAR, as the applicant

 - A written report had been supplied by PCSO Grace. Thirty-three incidents had been reported in Bentham including a burglary at Paxtons and 9 incidents at the care homes. No reports of anti-social behaviour around the Auction had been received. There had been an increase in quad bike thefts in other areas and residents were reminded to keep their property secure.
- 167. To Receive Reports from CCIIr & DCIIrs (for information only)
 - CCIIr Ireton confirmed that the NYCC Council tax rise would be 2.9% as permitted plus 2% for social care. He also told the meeting that the Highways Permit was now in force such that utilities would require a permit to dig up the road. The aim of this was to speed up repairs by closer supervision. The North Craven engineer, Gary Atkinson, has moved on and the new staff member for the area is Nicky Goodman.
 - DCIIr Thompson said that Craven had confirmed a balanced budget for the coming year, using money from reserves and a 2.99% increase in council tax (£5 Band D). The Extra Care facility is still in Planning and not expected to come to Committee, but he will support it if that does occur. Craven have received a £1.5 lottery grant to refurbish Skipton Town Hall which will be a superb facility for all Craven residents. Hornby Swimming Pool is being taken over by a management team from LCC.
 - He agreed to alert Craven Waste Management to the regular flytipper on Grasmere Drive

 - The Local Plan has a shortfall of designated employment land. The requirement is for 27-32ha, with only 16ha identified. Bentham is a Key Settlement and expected to have 25 new homes /year, or 14.6ha of new housing with no identified employment land by comparison Settle has 10ha of land for housing and 6.7ha designated employment land, and Ingleton 3.2ha and 2.94ha respectively.

The other concern was the suggested Affordable Housing provision at 87.4\$ 1-2 bed properties and 12.6% 3+ bed properties. Bentham is well served with the former and the Council recognises that this traps growing families in property that is too small, particularly if they have different sex children.

RESOLVED: That the Council comment on the lack of employment land provision in Bentham in the draft Local Plan

<u>RESOLVED:</u> That the Council comment on proposed Affordable Housing proportions, which does not provide for growing families.

NYCC Highways would adopt a pavement installed to highways standards. It was agreed that the clerk should find out exactly what this entailed and that Cllr Taylor would talk to the land owners. If they are in agreement then quotes can be sought from suitably ticketed contractors.

A request from a Low Bentham resident to solve the problem of dangerous parking around Crow Trees was discussed at length. Previous dealings with NYCC Highways have always shied away from double yellow lines as this will move the problem elsewhere, however it was agreed that the dangers of exiting Crow Trees need to be addressed

<u>RESOLVED:</u> That NYCC Highways be asked for a site meeting to discuss the possibility of installing yellow lines to improve safety in the area around Crow Trees

The road outside Felsteads requires the mud from the new development removing before there is an accident or the drains get blocked.

RESOLVED: That NYCC Highways be asked to get the road outside Felsteads cleaned

Various potholes were reported again and it was agreed to invite the new engineer out to the area to look at the problem

<u>RESOLVED:</u> That the new NYCC Highways engineer for the area be asked to meet with the Council to look at the poor state of the roads locally

The state of the fence on the Butts Lane footpath was discussed, but it is in private ownership.

The shrubs in the narrows at Lairgill are encroaching onto the road, but ownership of the land needs to be identified

The Council agreed that the Lower Hall could be used for a history display on 3-4 November prior to the Remembrance weekend.

The possible closure of Castleberg Hospital will lead to the provision of short term beds in Care Homes in Settle, Gargrave and Skipton and an extended range of community services such as night-sitting services, palliative care at home and a rapid response system for vulnerable people in crisis. The concern expressed was tat these services

would not be well placed to serve the northern part of Craven and that an alternative providing better services to this area should be considered.

<u>RESOLVED:</u> That the Council should respond asking for consideration of a better provision for services in north Craven including, potentially, emergency beds in Ingleton or Bentham
