Minutes of the Council Meeting held on Wednesday 14th December at 7.30pm in the Community Youth Building.

151. To Receive Comment & Concerns - None received

Mrs Brockbank raised her concerns and support for the Library as a Community asset and requested support from the Town Council for it.

152. To Confirm the minutes of the previous meeting

<u>RESOLVED:</u> That the minutes of the meeting on 4thth November 2015 & 16th November were signed and approved.

A group of residents attended the drop in session raising issue with the Councils response to the Planning application at Clay Barn.

155.To Receive the **Police Report** & allow members to ask questions for information No report received.

156. To Receive **Reports from County Cllr & District Cllrs** (for information only)

County Cllr Ireton reported that there was an agreement to complete Station Rd tarmacking but as yet it had not done due to the weather. There is no legal agreement behind this work. He also reported that the new school is leaking and the kitchens have been closed. Settlement of the Budget is anticipated shortly. Extra Care is still in the procurement stage but he confirmed that he would fight to get it into the second stage. Cllr Ireton thought it was unfair that volunteers have to fund raise for the Library.

Cllr Adams raised concerns that a lot of parents had complained that the school closure had caused issues because some had set off to work and considered it unreasonable that calls were sent out so late. It was suggested that a letter be sent to Chair of Governors.

District Cllr Brockbank gave the latest figure for housing in C raven has been released. Over 17 Years 483 have been allocated for Bentham. 56 houses for Burton in Lonsdale. Which is the highest apart from Skipton. No employment land had been designated it has been allocated to Ingleton instead. Cllr Brockbank requested views from the council by the end of January when the next Spatial planning meeting was to be held. The Spatial Planning meeting in March would be when CDC will be discussing sites. Councils will only get a week to comment when the Draft Local Plan of sites is released.

B6480 is closed but there were still spectators looking at the hole in the road. She urged caution to cyclists and pedestrians that vehicles were still using it and to be aware. CDC will have substantial cuts in the new budget. Cllr Townson asked for clarity on the Road Closure. Cllr Adams said all vehicles and pedestrians from the Road Closed barrier onwards were not allowed and would not be insured if there was an accident.

Cllr Marshall expressed concerned that given 483 houses over 17 years were designated for Bentham but there is no employment designation. There is a need for workspace for one/two man companies and storage. This would lead to growth within the Community. Cllr Vendy commented that in order to work in Ingeton you have to have a car. A response to be formed to pass to Cllr Brockbank before the next meeting Spatial Planning meeting.

An update was given by Cllr Marshall about the work. In the last 4/5 weeks when the workmen were observed which totalled 5 days only. It appeared to be a waste of time, money and effort. He considered it alarming that when a survey of an 8 foot hole was below water level needed filling was missed.

A response was received via email with an explanation and apologies were received from Andrew Mellor that no one was available to attend the meeting. £160K was being spent in Bentham on this project- this was reported on at NYCC Area Committee.

Temporary protection was in place but there was no confirmation of timescales for reopening. LCC and NYCC to patch routes. A permanent design solution is in hand.

Cllr Vendy reported that the School warning sign at school was not working because its solar panel is covered by tree and Cowls fitted on pedestrian lights were spinning round and the Bollards had gone.

Clean ditches where road drains. There are 2 down Station Road. Drains are blocked at Goodenber Road no 16 Goodenber Road and Sandy Hill Low Bentham Road.

The Sand bag store is now empty. CDC may collect stray sandbags. 150 taken from the store

It is not known if CDC plan to restock. Cllr Brockbank agreed to find out.

Tunnels got blocked caused problems for Hill Croft. Cllr Adams to send an email to Cllr Brockbank with this info. CDC Store to be reopened for people to bring back sand bags.

A request for the Council to support financially in some way. 400 users/members at the moment. Fund raising is required. Volunteers have tried to get someone to raise funds with no luck. Cleaners /caretaker required. Volunteers 24/7 to look after the building. There are a number of options to explore.

Move the library to Pioneer projects, Officers have looked at Pioneer projects and Wenningdale Room and Millers Court. A firm proposal is required from FOBL (NYCC officers look at suitability and costs and can then support the library) NYCC will refit and add in £3-4 K.

RESOLVED: In principle to support and also will look at financial support but the Council require a firm proposal

The Clerk to send a list of Play suppliers to Cllr Marshall. Trees on the other side may need attention in the future and may cause a problem. A site visit was suggested by Cllr Adams

Cllr Townson –reported on the Extra Care Group that had met twice and agreed that they are aware they need to move Bentham's case for care forward. NYCC seemed to have altered their approach to developing extra care facilities. A pool of developers and care and housing associations were involved in building mixed support facilities. Cllr Townson suggested that the Neighbourhood plan should have some mention of facilities for care and that S106 money may be able to go towards this.

Cllr Cowing reported back on the Refugee support group. 2 meetings had been well attended. Items for refugees to be collected to be held on 13th January 10-12 am at Bentham Town Hall. An Information day to be held at the Lower Town Hall Feb 6th 12-4 pm. A fundraising evening of entertainment to be held on the 12th March at the Methodist Hall. A welcome banner is being made.

Cllr Vendy reported back about the Defibrillators. Application had been made to the British Heart Foundation for 2 and a set of training dummies. If the equipment was bought by BTC they will be VAT free and the cabinets will be free of charge. A request to update the Asset register was made once the items were in place. The Lower Town Hall could be used for CPR sessions. The Surgery will have one on the outside of the building. An article for Bentham News will be submitted.

Community Youth Café AGM reported that funding was down on previous years. A Dragons Den night is planned to raise funds for the light and heating A new radiator is now installed thanks to BTC.

A successful tree tops trek was organised with well behaved children who were a credit to the parents.

Xmas activities - 12th Jan and Tuesday 22nd Dec Masterchef running into January.

Cllr Swales attended the NYCC Craven Area Committee and reported that the advertising campaign was successful in recruiting more firefighters.

Cllr Marshall reported on the Alms houses refurbishment plans.
