

MINUTES of the Council Meeting held on Monday 1 April 2019, at 7.30 pm in the Lower Town Hall.

The Council welcomed the returning councillor Brian Handford and the new councillor Howard Hill.

CCllr Ireton reported that the council is now approaching the ninth year of austerity, the chancellor stated in November that the national deficit is reducing but is still projected to be at 0.8% in 2023/24. So, austerity may be coming to an end but the council is likely to face another period of financial challenge well into and probably beyond the current MTFS period. The lack of a spending review beyond 2019/20 makes it very difficult to make predictions beyond 2019/20 but the sizeable increase in the funding planned for the NHS will mean that there is likely to be proportionately greatly financial pressure in other departments and that is likely to include local government.

By the end of 2018/19 the council will have made ongoing revenue savings of £157m since the beginning of this current period of austerity, this has been necessary due to increases in demand and the cost of providing services at the same time as government funding has declined. Demand, especially for older people, adults with learning disabilities and children with special education needs has grown significantly and is a strong feature of the year's budget. As a result, the council has to deliver its services in different ways to meet the challenge to do more with less.

For some time now there has been an acknowledgement that the pressures of adult social care are such that a national solution needs to be provided. The governments promised green paper has again been delayed and is now expected sometime in 2019. In the meantime, there have been numerous incremental interventions by government to help fund adult social care



which, whilst welcome, continue to be complex and in some cases cause tensions with health partners.

2019/20 is the fourth year in which the government have allowed those councils who provide social care the opportunity to generate an additional social care precept of 2% on the local tax.

219 Highway Matters

219.1 To Receive an update on the street light programme

It was reported that all the lights on Wenning Avenue should now be connected and working. Peter Ball from North Yorkshire Highways to instruct Electricity North West to connect the other street lights down Duke Street. There is a contractor appointed to do some cable ducting on our behalf and that will be carried out once the date for the electric supply to be connected is known.

219.2 To Consider and Note **Highway Matters** for information

It was reported that a number of street lights which have been reported as not working through the portal, are now recorded as having been fixed. However, this is not the case and none of them have been fixed. The reports closed down as having been fixed include one street light on corner of Lakeber Drive and Robin Lane that's been out for over a year and a half, two at the bottom of Robin Lane that have been out for a considerable time, and one opposite the school. All of these are now recorded as having been fixed but none of them have actually been fixed.

It was reported that the dog fouling problem in Bentham is getting worse and also that DCIIr Thompson offered the use of some covert cameras several meetings ago, but that these have not yet arrived.

RESOLVED: Clerk to provide Cllr Handford with 20 more sticky signs about dog fouling to be displayed on lampposts.

RESOLVED: Cllr Handford to remove and dispose of the old signs saying that members of the public may be videoed.

RESOLVED: Clerk to ask for update on position re use of covert cameras.

It was reported that there have been several requests by members of the public for more dog poo bins, and it was explained that bagged dog waste can be disposed of in any bin. However, the point being made by members of the public is that there are not sufficient bins along the popular dog walking routes. But it needs to be born in mind that any bin must be situated where Craven District Council are willing to collect it, so on the public highway or adjacent to it, and not down a footpath or across a field.

RESOLVED: Cllr Wills to draw up a list of the areas in question and indicate where along the route would be a suitable position for a bin to be located.

RESOLVED: Craven District Council will then be asked to provide bins.

The narrow stretch between Mount Pleasant and Lairgill has been resurfaced which is appreciated.
