The clerk informed the meeting that there would be a Planning Site Meeting at Rose Cottage, Wenning Avenue on 13 March. Cllr Marshall agreed to attend.

PC Parsons reported that there had been 55 reported incidents in February including 17 relating to the Care Homes & Cedar House School, 10 crimes and an RTA. The crimes included 4 thefts, a sexual offence, 2 reports of damage to vehicles and 4 incidents of slashed tyres. Commenting on the level of reported problems at the schools, PC Parsons said that part of the problem was the more challenging cliental following decisions to keep children in mainstream schools for as long as possible. She agreed that Bentham residents needed to be less complacent about theft & burglary and property safety as many incidents were being perpetrated by people travelling out of the towns. It was suggested that Bentham News should report on this

DCIIr Brockbank announced that the Allerton waste recovery plant will be operational in 2018. The Library volunteers have filled the rota for April, meaning that the library will be open as per the hours when it was run by NYCC. Craven DC have agreed to do some remedial work on the Grasmere Close footpath, and she asked whether the Council might be prepared to help with upgrading the lighting. It was agreed that this subject should be put on a future agenda.

CCIIr Ireton commented on the coming budget, saying that it was hoped that Chancellor would find new money for Adult Social Care, as the 2% announced by NYCC was barely sufficient to allow the service to standstill following the increased costs associated with the new living wage and pension requirements.

The blocked gully at Furness Drive has been cleared, but the ones at One Ash, Rest Harrow and at the Toll Bar Nurseries still need clearing. CCllr Ireton agreed to chase up the Toll Bar Nurseries as this is still holding up the development. The clerk will continue to press for the others to be cleared. It was noted that the gullies on the eastern side of Goodenber Road are all blocked as well.

A new pothole on Burton Road was reported and a missing speed sign above Pye Busk

Cllr Handford had discussed the dog fouling problems on Springfield / Mount Pleasant with Craven Environmental Health, who can install CCTV cameras to catch offenders. Warning signs will be erected shortly warning of a £50 fine for the first offence, plus a £1000 fine and a court appearance for subsequent offences.

It was noted that the Millenium Trust had LEADER funding available to Councils which could be potentially used for footpath improvements.
