BENTHAM TOWN COUNCIL

Minutes of the Council Meeting held on Monday 4 December, at 7.30 pm in the Lower Town Hall

Present Cllrs Adams, Bridgeman, Faraday, Handford, Stannard, Swales, Taylor, Townson & Vendy. Also DCllr Thompson, CCllr Ireton, the clerk Mrs Burton, the coordinator Mrs Hawkins and 3 parishioners

Prior to the meeting members met with Rev Anne Russell from the Youth Café Management Committee. The committee have been conducting a feasibility study looking at the use of the Community Youth Building and the needs of the community – children, young people & families. The youth leaders had stepped down at the end of the summer due to altered work commitments, so the committee had taken the opportunity to approach stakeholders e.g. Stronger Communities, 4Youth (NYCC), the school, young people etc. Currently volunteers are mainly from churches with very few parents, so there is a need to employ another youth worker(s) to take the project forward. The café is open just one night per week at the moment for 8-15 yr olds – the desire is to widen provision and perhaps split the age groups into different evenings. Rev Russell agreed to keep the Council informed and it was agreed that, as landlords, the Council would consider any requests for change to the current agreement as it was vey supportive of the project's continuation as there is no other real youth provision in the area.

A member of Bloomin' Bentham encouraged the Council to get behind the knitted poppy project (item 131.3) and encourage organisations to get involved.

Although unable to attend, a police report had been sent. There had been 2 RTCs without injury in the past month. There had also been 3 thefts/burglaries, two assaults with either arrest or person under investigation and a report of harassment again with an individual under investigation. A shop window had been broken and the offender dealt with by community resolution disposal. The 2 new safety camera vans are now based in Skipton giving daily coverage to Craven's roads, not just for speeding but also using a mobile phone or lack of seat belts.

126.To Receive Reports from CCllr & DCllrs (for information only)

CCIIr Ireton reported that NYCC was reviewing its Area Committees with a view to moving to parliamentary boundaries, combining Craven with Ripon – giving a very large area with nothing in common, which would be a bad idea in his opinion. The planning application for the Extracare provision had gone in and, if passed first time, would mean building starting in summer 2018 and completion in early 2019, with units being allocated (by a multi-agency panel) in January 2019. He thanked the Extracare Group for driving this project to this point.

DCIIr Thompson said that there would be a special meeting of Craven District Council on 19 December which was expected to approve submission of the Local Plan to the Planning Inspectorate – which would hopefully be a relatively short process before approval.

He reiterated that local businesses were welcome to apply for LEADER funding to improve efficiency or provide extra employment. As this area was considered to have one of the better committees extra funding will be found over and above the designated £2.9m for projects fulfilling the criteria.

He agreed that CCTV was required to catch fly-tippers at Grasmere Drive and would talk to the relevant officers.

There was some discussion regarding the provision of parking – with only 39 spaces for the 72 accommodation places but the Council voted 6:3 against expressing any concerns

128. Highways Matters

128.1.

To receive an information on the meeting with Frank Crossley regarding The Rose Garden proposal Cllrs Marshall & Stannard and the clerk had met with Frank Crossley to consider the proposal. The visibility splay is not good and would require a speed survey showing that traffic travels at 25mph or less approaching the entrance. The area is not wide enough to allow two rows of vehicles and manoeuvring space to exit the Rose Garden, so a maximum of 8 vehicles could be parked on the land, with a loss of 6 on-road parking spaces. It was agreed that the expected costs of the project would far out-weigh the benefits.

RESOLVED: That the Council does not progress the proposal to turn the Rose Garden into a car park as the benefits would be negligible and outweighed by the costs.

128.2. To discuss the recent flooding on Hillcroft

The recent wet weather had seen flooding on Hillcroft as the drains in the area were blocked and the Church Beck culverts partially silted up. It was also reported that the drain outlet into the river at 12 Hillcroft was damaged and not working. Sandbags had kept the internal flooding to a minimum but the problem needs solving quickly.

RESOLVED: That NYCC Highways be asked to clear the drains on Station Road & Hillcroft and look at the river outlet as soon as possible

That Graham Tarn of Craven Environmental Health be asked to look at the RESOLVED: Church Beck culverts following his resolution of the problems last time they were blocked.

There was also flooding in Low Bentham the same evening. Residents had commented that a sand bag store in Low Bentham would be helpful rather than collecting them from Grasmere Drive when the weather is bad. Council agreed that it could provide a shed if somewhere to place it could be found and Craven would agree to stock it.

RESOLVED: That Environmental Health be asked if they would stock a sand bag store in Low Bentham if the Council could provide one.

That the Victoria Institute be asked if the Council could site a sandbag store **RESOLVED:** behind the Institute if Craven would stock it

128.3. To discuss the state of the path between Hillside Road and Ellergill and agree a way forward. The footpath currently gets very muddy and slippery. As it is a well-used route which will only get busier once the play area opens, it was agreed that the Council should look to improve it if it can get permission from the landowners.

RESOLVED: That the Council should look to improve the footpath if the landowners will give permission.

- 128.4. To note LCCs proposed major maintenance to Greyhound Bridge on the A589 in 2018 - noted
- 128.5. To Consider and Note Highway Matters for Information Some drains on Low Bentham Road have been cleared, but not those by the telephone Exchange which is the lowest point, and water is still collecting. Station Road & Clapham Road drains are also blocked and need urgent attention

RESOLVED: That NYCC Highways be asked to look at these drains as a matter of urgency when they start clearing drains on 15 December

The problems with the subsidence at manholes / metal covers outside the Co-Op and on Springfield was raised again as they are getting worse.

RESOLVED: That NYCC Highways should be asked to look this subsidence as soon as possible The footpath needs extending between the Bowling Green and the end of Pye Busk. This is currently grassed and causes problems for the elderly residents of Pye Busk and the members of the Bowling Club

<u>RESOLVED:</u> That NYCC Highways be asked to consider extending the footpath to Pye Busk There are an increasing number of vehicles parking on pavements in Bentham making it difficult for pedestrians, particularly those with pushchairs etc.

<u>RESOLVED</u>: That Parking Enforcement be asked if they can do anything about vehicles blocking pavements

With the dark nights dog fouling is on the increase again and Craven should be asked to look at installing CCTV again.

RESOLVED:That Craven DC be asked about CCTV to catch those allowing dog foulingThere are potholes on the B6480 between St Johns and the railway bridge that need attentionRESOLVED:That NYCC Highways be asked to look at the potholes on the B6480 near St Johns

- 130.To Receive a report from the Chairman regarding his recent meeting with the Headmistress of Bentham Primary School

The Chairman had been updated on the closure of the school gates, which had now been resolved. The headmistress had also raised three other subjects. The Governors were looking at the original planning application for the school and the reasons behind the lack of provision of a 'pull-in' for dropping off of pupils. The move of the Library to the Looking Well means that the school now uses the south side of the street to get to it. This means using the narrow pavement at Bentham Hall which means going into the road as there is no safe place on the Main Street for the pupils to cross further up. Mrs Pearson wondered if it might be possible to remodel the pavement in this area to make it wide enough or provide a safe refuge area. (CCIIr Ireton suggested that the school should raise this with John Lee at County.)

The school is still working on an outstanding list of defects from its original construction

131. To Discuss the possible Commemorative Events in Bentham for the centenary of the end of WW1
