A member of the public shall not speak for more than 3 minutes).

MOP 1 Regarding agenda item 261; spoke about closure for the passing of his wife, stone masons were awaiting instructions for the inscription, allow to put his details on the headstone to save the headstone being collected and taken back to Morecambe to be added to, the

stone masons can come and put the date on.

MOP 2 Regarding agenda item 261; stated that the gentleman has no other family around here

and it would put his mind at rest if this is allowed.

Cllr Marshall asked if this has occurred in other areas in the UK? Cllr Adams explained that yes this does occur around the UK, predominantly larger towns, their Policies are no

different from Bentham Town Council, but do allow.

PCSO Jayne Grace and PC Ian Hunt. PCSO stated that there has been an increase in burglaries and vans broken into within the area. PCSO said that the public are not reporting incidents, for example strangers on private property. There has been an increased presence of Constabulary around the area. Certain vulnerability located in the area as the Parish is isolated and rural, and on the edge of the County border. Encouragement to contact Police, as incidents are often linked.

PCSO's encouraged prevention; ensure keys are removed from vehicles.

Incident noted of two balaclava wearing men spotted near the Lancashire border of Parish.

PC Hunt explained that they are in a vicious cycle of public thinking constabulary has limited resources so people are not reporting incidents, however if more were reported there would be more available. Cllr Burton questioned which numbers to contact on? If something is happening 'now' as in a stranger on your property report to 999, if after the incident 111.

PC Hunt stated that the Ellergill driveway parking issue has been investigated, this is not a junction, there does not seem to be an obstruction, this is private land and not highway.

The front passenger side window was smashed, and the side sliding door was ripped off. £4000 worth of power tools were stolen from within (incident #12240021137).

05.02.24 - theft of an old blue Toyota Landcruiser parked on a driveway on Clapham Road, High Bentham which occurred between 01:00hrs – 02:30hrs on Monday 5th February. The stolen vehicle was sighted near Claughton by a Lancashire Police Unit. It was in convoy with a dark coloured Audi on cloned plates. They were pursued and the offenders abandoned the Toyota on a bridge on Low Road near Halton Green/Crook of Lune. The Toyota was left in a position where it was completely blocking the bridge. The occupants of the stolen vehicle jumped into the Audi which made off from the officer who was unable to follow (incident #12240021634)
